A SPA is being submitted for the Pharmacy Access Act which will allow pharmacists to be reimbursed at parity for birth control services via medical. Kim Bristow did place the FFS Preferred Drug List (PDL) on the SC DHHS website. Additionally, Lisa Correll provided an overview of the new drugs to market.
