SUBJECT: Medicaid Tamper Resistant Prescription requirement Delayed

President George W. Bush signed legislation passed by Congress (H.R. 3668) to delay by 6 months the mandatory use of tamper-resistant prescription pads in state Medicaid programs. South Carolina Medicaid will delay implementing this new requirement for 6 months with a new implementation date of April 1, 2008.
