Pharmacy and Therapeutics (P&T) Committee Meeting August 2, 2006 MINUTES

1. Call To Order

Mary Roberts reviewed statistics that reflect the changes that have occurred with South Carolina's Medicaid program as a result of the implementation of the PDL and Medicare Part D.
